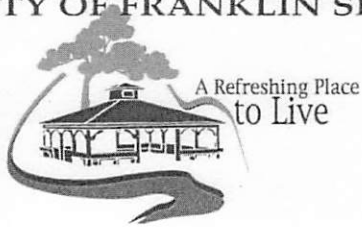

Tommy Pritchett made a motion to approve a business application for Golden Royal Cleaning Specialist. Tom Wilson seconded. Motion carried.

Tom Wilson made a motion to approve a business license for Advantage Home Solutions, LLC. Bill Bell seconded. Motion carried.

Jessica Moorhead: wanted to try and get an update on timeline for wastewater. Stated she was selling the property on 145 and talked with some developers who are interested in the property. The last contract she had was terminated because of the cost of lifting the wastewater up to 29. She wanted to show her support of the project and see if she could get any update on the timeline.

Mayor Moore: We can get you an answer to that a little more concrete in the near future, and you do a great job of staying in touch with us and we appreciate you being here tonight.

Mayor Moore: so the answer is still the same. No.


Lynn Briley: still no? Thank you for answering. I appreciate it.
